

**Commonwealth of Kentucky  
City of London  
Revisions to Ordinance No. 2009-06  
Effective February 1, 2012**

Section 5.0 and 6.0 of Ordinance No. 2009-06 states that the water and sewer rates will be adjusted annually based on the Consumer Price Index for the preceding year. During the period from December 2010 to December 2011, the CPI increased by 3.00%. Documentation is available from the Department of Labor which reflects the increase. The new rates will become effective February 1, 2012.

**Section 2:** Each customer of the water system located inside the city limits shall have a separate water meter and shall pay a monthly meter service charge, which shall include the first 2,000 gallons, based on the size of the meter as follows:

**Section 4:** Each customer of the water system located outside the city limits shall have a separate water meter and shall pay a monthly meter service charge, which shall include the first 2,000 gallons, based on the size of the meter as follows:

Monthly Rate Schedules**

Each customer of the wastewater treatment and collection system located inside the city limits shall pay a monthly minimum service charge of \$12.42 which shall include the charge for the first 2,000 gallons of wastewater. The rate schedule for the sewer charges for each customer located inside the city shall be as follows:

**Sewer User Charge

Each customer of the wastewater treatment and collection system located outside the city limits shall pay a monthly minimum service charge of \$15.73 which shall include the charge for the first 2,000 gallons of wastewater.
