Commonwealth of Kentucky City of London Revisions to Ordinance No. 2009-06 Effective February 1, 2024

Section 5.0 and 6.0 of Ordinance No. 2009-06 states that the water and sewer rates will be adjusted annually based on the Consumer Price Index for the preceding year. During the period from January 2023 to December 2023, the CPI increased by 3.4%. Documentation is available from the Department of Labor which reflects the increase. The new rates will become effective February 1, 2024.

<u>Section 2:</u> Each customer of the water system located inside the city limits shall have a separate water meter and shall pay a monthly meter service charge, which shall include the first 2,000 gallons, based on the size of the meter as follows:
